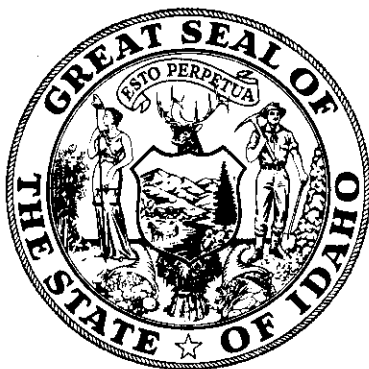

ARTICLES OF INCORPORATION
OF

THE TWIN RIVERS GENEALOGY SOCIETY, INC.

KNOW ALL MEN BY THESE PRESENT, THAT WE, THE UNDERSIGNED EACH OF WHOM IS A BONAFIDE CITIZEN OF THE UNITED STATES OF AMERICA, AND EACH OF WHOM IS A NATURAL PERSON OF FULL AGE, HAVE VOLUNTARILY ASSOCIATED OURSELVES TOGETHER FOR THE PURPOSE OF FORMING A NON-PROFIT CORPORATION UNDER THE LAWS OF THE STATE OF IDAHO AND WE DO HEREBY CERTIFY:

ARTICLE I

THE NAME OF THE CORPORATION IS; THE TWIN RIVERS GENEALOGY SOCIETY, INC.

ARTICLE II

THE CORPORATION SHALL HAVE PERPETUAL EXISTENCE, AND ITS PURPOSE IS TO GIVE MUTUAL ASSISTANCE IN GENEALOGY RESEARCH.

ARTICLE III

THE LOCATION OF ITS PRINCIPAL PLACE OF BUSINESS AND THE REGISTERED OFFICE OF THIS CORPORATION IS HEREBY DESIGNATED AS LEWISTON, IDAHO, NEZ PERCE COUNTY. PHYSICAL LOCATION SHALL BE THE ADDRESS OF ITS PRESIDENT, CURRENTLY, MELVIN AND BETTY METCALF, 1021 10TH AVE., LEWISTON, IDAHO.

ARTICLE IV

THIS CORPORATION IS ORGANIZED EXCLUSIVELY FOR RELIGIOUS, CHARITABLE, SCIENTIFIC, LITERARY OR EDUCATIONAL PURPOSES WITHIN THE MEANING OF SECTION 501 (c) (3) OF THE INTERNAL REVENUE CODE.

NOTWITHSTANDING ANY OTHER PROVISION OF THESE ARTICLES, THE CORPORATION SHALL NOT CARRY ON ANY OTHER ACTIVITIES NOT PERMITTED TO BE CARRIED ON BY AN ORGANIZATION EXEMPT FROM FEDERAL INCOME TAX UNDER SECTION 501 (c) (3) OF THE INTERNAL REVENUE CODE.

UPON THE WINDING UP AND DISSOLUTION OF THIS CORPORATION, AFTER PAYING OR ADEQUATELY PROVIDING FOR THE DEBTS AND OBLIGATIONS OF THE ORGANIZATION, THE REMAINING ASSETS SHALL BE DISTRIBUTED TO A NONPROFIT FUND, FOUNDATION OR CORPORATION WHICH HAS ESTABLISHED ITS TAX EXEMPT STATUS UNDER SECTION 501 (c) (3) OF THE INTERNAL REVENUE CODE.

ARTICLE V

THE CORPORATION SHALL ISSUE NO STOCK, MEMBERSHIP SHALL BE OBTAINED BY PAYMENT OF YEARLY DUES, NO MEMBER CAN HAVE OR ACQUIRE A GREATER INTEREST IN THE CORPORATION THAN ANY OTHER MEMBER. MANAGEMENT OF ITS AFFAIRS IS TO BE VESTED IN ITS MEMBERS PURSUANT TO SECTION 30-314(c) IDAHO CODE.
