

ARTICLES OF INCORPORATION  
OF  
MOUNTAIN HOME SHEEP COMPANY.

KNOW ALL MEN BY THESE PRESENTS: That we, the undersigned, have this day voluntarily associated ourselves together for the purpose of forming a corporation under the laws of the State of Idaho, and do hereby certify:

I.

That the name of said corporation is MOUNTAIN HOME SHEEP COMPANY.

II.

That the purposes for which this Company is formed are:

To carry on the business of buying, selling, mortgaging, raising and handling of sheep and cattle for profit;

To buy, sell, lease, mortgage and otherwise deal in real and personal property of every kind and description and wheresoever situate;

To buy, sell and deal in notes, bonds or debentures and to pledge and hypothecate the same.

III.

That the principal place of business of said corporation is to be at Boise, Ada County, Idaho.

IV.

That the term for which this corporation is to exist is fifty (50) years from and after the date of its incorporation.

V.

That the number of Directors shall be three (3).

VI.

That the amount of capital stock of this corporation shall be Two hundred fifty thousand (\$250,000.00) Dollars, divided into two hundred fifty thousand (250,000) shares of stock of the par value of One (\$1.00) Dollar each.

VII.

That the amount of the capital stock which has been actually subscribed is three (3) shares and that the following are the names of the persons by whom the same has been subscribed, to-wit:
