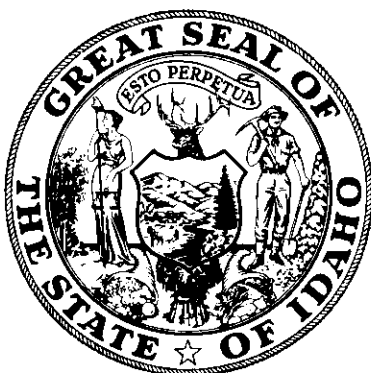

ARTICLES OF INCORPORATION  
OF  
IDAHOANS DETERMINED to ACHIEVE HONOR & OPPORTUNITY, INC.

The undersigned, acting as incorporators of a corporation under the Idaho Business Corporation Act, adopt the following Articles of Incorporation for such corporation:

ARTICLE I.

The name of the corporation is IDAHOANS DETERMINED to ACHIEVE HONOR & OPPORTUNITY, INC.

ARTICLE II.

The period of its duration is perpetual.

ARTICLE III.

The purposes for which the corporation is organized are:

1. Voter education;
2. The transaction of any and all lawful business for which corporations may be incorporated in the State of Idaho.

#### ARTICLE IV.

This corporation is organized under the Idaho Non-profit Corporation Act and is to be a non-profit corporation.

#### ARTICLE V.

This corporation shall consist of one or more classes of members, the designation of such class or classes, the manner of election or appointment, and the qualifications and rights of the members of each class, shall be set forth in the By-Laws.

#### ARTICLE VI.

The initial registered office of this corporation shall be 255 North 16th, Boise, Idaho 83702. The initial registered agent of this corporation shall be James E. Kerns, 255 North 16th, Boise, Idaho 83702.

#### ARTICLE VII.
