The undersigned incorporator, desiring to form a corporation pursuant to the provisions of the Idaho Nonprofit Corporation Act, adopts the following articles of incorporation:

ARTICLE ONE
Name

The name of the corporation is Idaho District No. One Little League Baseball, Inc..

ARTICLE TWO
Purposes

The purpose of the corporation is for charitable purposes, and specifically to administer, guide, educate, support, and promote the policies, rules, regulations, and guidelines of Little League Baseball, Incorporated and, for such purposes, to make distributions to organizations chartered by Little League Baseball, Incorporated and that qualify as exempt organizations under 26 U.S.C. §§ 501(c)(3) and 501(a) or the corresponding section(s) of any future federal tax code.

ARTICLE THREE
Duration

The period of duration of the corporation is perpetual.

ARTICLE FOUR
Registered Office and Agent
