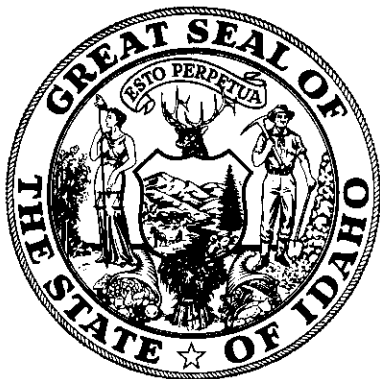
CERTIFICATE OF INCORPORATION OF

ARTICLES OF INCORPORATION
of

The undersigned, acting as incorporator of a corporation under the Corporation Laws of the State of Idaho, do hereby adopt the following Articles of Incorporation for such corporation.

SECRETARY OF STATE

ARTICLE I

Corporation Name: The name of the corporation is COMPUDRAFT INC.

ARTICLE II

Duration: The duration of this corporation shall be perpetual

ARTICLE III

Purposes: To carry on all or any of the business of a computer firm and to do all other things necessary and relating thereto. The transaction of any or all lawful business for which corporations may be incorporated.

ARTICLE IV

Stocks: The corporation shall have the authority to issue one hundred (100) shares, no par, stock. The shares are to consist of one (1) class only.

ARTICLE V
