REDEEMER LUTHERAN CHURCH OF KIMBERLY, IDAHO, INC.

was filed in the office of the Secretary of State on the **Twenty-ninth** day of **December,** A. D. One Thousand Nine Hundred **Sixty-one** and is duly recorded on Film No. **114** of Record of Domestic Corporations of the State of Idaho, and that the said articles contain the statement of facts required by Sections 30-103, 30-1101 and 30-1102, Idaho Code.

AND I FURTHER CERTIFY, That the persons executing the articles and their associates and successors are hereby constituted a corporation, by the name stated in the articles, and for **perpetual existence** from the date hereof, with its registered office in this State located at **Kimberly** in the County of **Twin Falls** and as such are subject to the rights, privileges and limitations granted to Religious, Ex-Service Men, Benevolent, Charitable and Fraternal Corporations, as provided in Chapter 11, Title 30, Idaho Code.

ARTICLES OF INCORPORATION
OF
REDEEMER LUTHERAN CHURCH OF KIMBERLY, IDAHO

KNOW ALL MEN BY THESE PRESENTS: That we, Gerald Sievers, Robert Sherman and Melvin Vinkenberg, all of Twin Falls County, Idaho, and citizens of the United States, duly elected and qualified directors of the Redeemer Lutheran Church of Kimberly, Idaho, pursuant to a resolution adopted at a special meeting held on December 10th, 1961, at 8:00 o'clock P.M. at the American Legion Hall in Kimberly, Idaho, together with the other voting members of said church for the purpose of forming a religious corporation under the laws of the State of Idaho, and for this purpose we do hereby certify and declare:

ARTICLE I

The name of this corporation is and shall be: REDEEMER LUTHERAN CHURCH OF KIMBERLY, IDAHO, INC.

ARTICLE II

The location and postoffice address of this corporation shall be at Kimberly, Idaho.

ARTICLE III

The object of this corporation is and shall be the maintenance of said association for the purpose of preaching the word of God, the administration of the Sacraments, the religious instruction of youth and adults, and the ministrations of charity, in accordance with the confessional standards and practices of the Lutheran Church, Missouri Synod.

ARTICLE IV

The corporation shall have incident to the principal purpose set out above, the power and authority to receive, acquire, hold, purchase, dispose of, convey, mortgage and/or lease real and personal property, to dispose of, sell, lease, sign, transfer,

1 mortgage and/or convey, any rights, privileges, franchise, real
2 or personal property of the corporation, and to acquire real or
3 personal property by gift, donation, legacy or otherwise, and to
4 generally do such acts and things that may be required to carry
5 out the purpose of the corporation.

6 ARTICLE V

7 The corporation is to have perpetual existence, subject
8 only to dissolution in the manner provided by law.

9 ARTICLE VI

10 This corporation shall be managed by a Board of Trustees
11 which at no time shall consist of less than three nor more than
12 100 members. A trustee must be a male voting member of the
13 corporation, a citizen of the United States who has attained the
14 age of twenty-one years, and must sign the constitution and by-
15 laws of the corporation.

16 ARTICLE VII

17 The trustees shall administer all of the property of said
18 corporation, real and personal, and all its legal and financial
19 business in accordance with the articles of incorporation and
20 with such constitution, by-laws and resolutions as said corpora-
21 tion may from time to time adopt.

22 ARTICLE VIII

23 The first annual meeting of said corporation shall be held
24 on the third Sunday in October of 1962, and subsequent annual
25 meetings shall be held on the third Sunday of October of each
26 year unless a different date is fixed by the constitution and
27 by-laws of the corporation. The time and place of the annual
28 meetings together with its purpose, including the election of
29 the Board of Trustees, shall be made known to all voting
30 members of said corporation at least ten days prior to the date
31 of such meeting.

32 The trustees shall be elected at the annual meeting of the

1 corporation by a majority ballot of members of the corporation
2 present at such meeting. The Board of Trustees shall be elected
3 in such a manner and for such a term of office as the corporation,
4 by its constitution and by-laws, shall provide. In case of a
5 vacancy on the Board of Trustees, the corporation shall at the
6 next regular meeting after such vacancy shall occur, or at a
7 special meeting, upon proper notice to all voting members of
8 said corporation, by giving at least ten days notice prior
9 thereto, fill such vacancy by election.

10 ARTICLE IX

11 A meeting of the Redeemer Lutheran Church of Kimberly, Idaho,
12 was held on the 10th day of December, 1961, at 8:00 o'clock P.M.
13 and notice of the time, place and purpose of said meeting was
14 duly given by publication in the Kimberly Advertiser, a newspaper
15 published at Kimberly, Idaho, for two weeks prior to the holding
16 of said meeting and by posting a like notice in a conspicuous
17 place in the building where such election was held for the same
18 length of time. That at said meeting the following persons,
19 whose postoffice addresses are set opposite their respective
20 names, to-wit:

23 Melvin Vinkenberg, Kimberly, Idaho

24 were duly elected as, and now are, the trustees of said corpora-
25 tion to serve as such trustees until their successors have been
26 duly elected and have qualified.

27 ARTICLE X

28 Attached hereto and incorporated herein is the certificate
29 of the secretary of said meeting verifying the facts herein set
30 forth regarding the election of the above named trustees.





I further certify that a special meeting of the voters assembly of Redeemer Lutheran Church of Kimberly, Idaho, was held on the 10th day of December, 1961, at the hour of 8:00 o'clock P.M. at the American Legion Hall on Center Street in Kimberly, Idaho, for the purpose of authorizing the incorporation of said association according to law and for the purpose of electing trustees who shall have charge of the operation and management of the property and business affairs of said corporation.
