

# THREE RIVERS REFINERY, INC.

We, the undersigned natural persons of the age of twenty-one years or more, at least two of whom are citizens of the State of Texas, acting as incorporators of a corporation under the Texas Business Corporation Act, do hereby adopt the following Articles of Incorporation for such corporation.

## ARTICLE ONE

The name of the corporation is THREE RIVERS REFINERY, INC.

# ARTICLE TWO

The period of its duration is perpetual.

## ARTICLE THREE

The purpose for which the corporation is organized is to purchase, process, manufacture, and sell goods, wares, and merchandise of all kinds.

# ARTICLE FOUR

The aggregate number of shares which the corporation shall have the authority to issue is ten thousand (10,000) shares of the par value of Ten Dollars (\$10.00) each.

# ARTICLE FIVE

The corporation will not commence business until it has received for the issuance of its shares consideration of the value of One Thousand Dollars (\$1,000.00) consisting of money, labor done, or property actually received.

# ARTICLE SIX

The post office address of its initial registered office is 3643 East Commerce Street, San Antonio, Texas, and the name of its initial registered agent at such address is Tom E. Turner.

Pursuant to the provisions of Article 4.01-4.06 of the Texas Business Corporation Act, the undersigned corporation adopts the following Articles of Amendment to its Articles of Incorporation in order to change the Corporation's name from its present name, THREE RIVERS REFINERY, INC., to its new name, SIGMOR REFINING COMPANY.

#### ARTICLE I

The present name of the corporation is THREE RIVERS REFINERY, INC.

#### ARTICLE II

The following amendment to the original Articles of Incorporation was adopted by the shareholders of the corporation on the 20th day of January, 1976.

"Article I. of the Articles of Incorporation is hereby amended to read as follows:

'Article I. The name of the corporation is SIGMOR REFINING COMPANY.

The wording of the original Article I is deleted in its entirety and the above wording is substituted as the entire Article I permanently changing the name of the corporation to SIGMOR REFINING COMPANY.

#### ARTICLE III

The number of shares of the corporation outstanding at the time of such adoption was 5,000 shares and the number of shares entitled to vote thereon was 5,000 shares.

All stock is common stock and of the same class.

## ARTICLE IV

The holders of all of the shares outstanding and entitled to vote on said amendment have signed a consent in writing adopting said amendment.

#### ARTICLE V

The amendment involves no exchange, reclassification, or cancellation of issued shares.

### ARTICLE VI

The amendment does not effect any change in the amount of stated capital.
