



ARTICLES OF INCORPORATION OF KREITZBERG ASSOCIATES, INC.

KNOW ALL MEN BY THESE PRESENTS:

That the undersigned natural person, of lawful age, acting as incorporator of a corporation under the Montana Business Corporation Act, does hereby adopt the following Articles of Incorporation:

ARTICLE I.

The name of the corporation is "KREITZBERG ASSOCIATES, INC."

ARTICLE II.

The period of duration of the corporation is perpetual.

ARTICLE III.

The purpose for which the corporation is organized is to conduct a real estate brokerage business; to purchase, sell, lease, hold for investment, any and all kinds of real and personal property. The corporation shall have all powers granted a business corporation by the Montana Business Corporation Act, or any amendments thereto.

ARTICLE IV.

The amount of the authorized capital stock of this corporation is Fifty Thousand Dollars (\$50,000.00), divided into five hundred (500) shares of par value of One Hundred Dollars (\$100.00) each. All of said stock shall be common stock and non-assessable.

ARTICLE V.

Shareholders of the corporation shall have the full pre-emptive rights to acquire unissued or treasury shares of the corporation, or obligations of the corporation convertible into such shares.
