



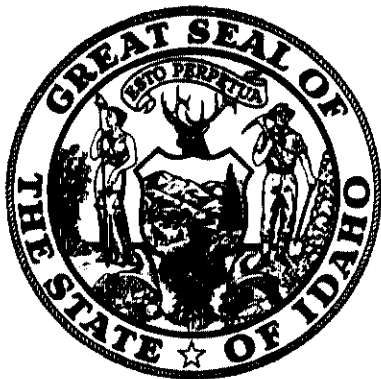
CERTIFICATE OF INCORPORATION

The undersigned incorporators set forth the following
Articles of Incorporation of Outback Land & Cattle Company, Inc.

ARTICLE 1

NAME

The name of the corporation is Outback Land & Cattle
Company, Inc.

ARTICLE 2

DURATION

The period of duration of the corporation shall be
perpetual.

ARTICLE 3

PURPOSE

The purpose for which the corporation is organized is the
transaction of any and all lawful business for which corporations
may be incorporated under the Idaho Business Corporation Act.

NUMBER OF SHARES

The corporation shall have authority to issue one
