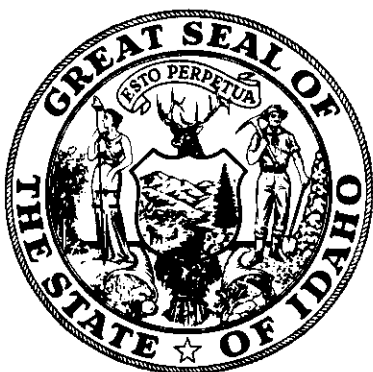

ARTICLES OF INCORPORATION

OF

STATE  
PATTERSON FARMS OF IDAHO, INC.

The undersigned, acting as incorporator of a corporation under the Idaho Business Corporation Act, adopt the following Articles of Incorporation for such corporation:

FIRST: The name of the corporation is PATTERSON FARMS OF IDAHO, INC.

SECOND: The period of its duration is perpetual.

THIRD: The purpose or purposes for which the corporation is organized are:

Agri-business and any or all other lawful business as permitted by law.

FOURTH: The aggregate number of common shares which the corporation shall have authority to issue is 5000 shares without par value.

FIFTH: The address of the initial registered office of the corporation is Route # 1-Box 81, Paul, Idaho 83347 and the name of its initial registered agent at such address is Lloyd L. Patterson.
