ARTICLES OF INCORPORATION

The undersigned, for the purpose of forming a corporation under the non-profit laws of the State of Idaho, declare the following:

ARTICLE I

The name of the corporation shall be MOPARS UNLIMITED OF IDAHO, INC.

ARTICLE II

The term of existence shall be perpetual.

ARTICLE III

The purposes for which the corporation is organized are as follows:

1. To promote the preservation and restoration of motor vehicles produced by Chrysler Corporation (MOPAR).
2. To provide a common meeting place for the membership to accomplish the purposes of the organization and promote goodwill among themselves and their sport.
3. To encourage and provide education opportunities for MOPAR enthusiasts in order to increase their knowledge, understanding and appreciation of techniques and ideas involving maintenance, repair, restoration and/or performance improvements of all Chrysler (MOPAR) motor vehicles.
4. To support and promote courteous and safe behavior and driving habits on our streets and highways by all motorists.

5. To provide a forum for Chrysler (Mopar) enthusiasts to respond and have their voices heard at all levels of government on laws and/or regulations which will have a bearing on their sport; whether it be racing, street rodding, restoration, or performance.

#### ARTICLE IV
