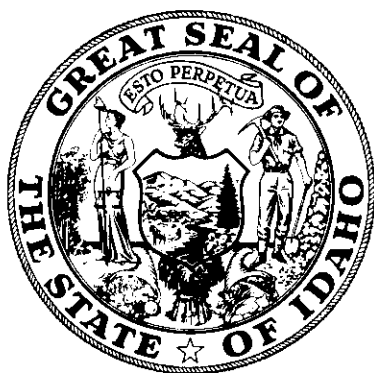

ARTICLES OF INCORPORATION  
OF

We, the undersigned incorporators, hereby associate ourselves together to form and establish a corporation not for profit under the laws of the State of Idaho pursuant to Title 30, Chapter 3, Idaho Code.

I.

The name of the corporation is COMMUNITY CHRISTIAN CENTER OF BONNERS FERRY, INC.

II.

The duration of the corporation is perpetual.

III.

The street address of its initial registered office and the name of its initial registered agent at such street address is:

This corporation is organized NOT for profit and the objects and purposes to be transacted and carried on are to acquire and hold property, both real and personal for the purpose of conducting and operating a community Christian center which center shall conduct activities to promote the following:

- B. The administration of the ordinances of the New Testament.
