The Association of Classical and Christian Schools, Incorporated

The undersigned, a majority of whom are citizens of the United States as incorporators of a nonprofit corporation in accordance with the provisions of the Idalia Non Corporation Act, do hereby adopt the following Articles of Incorporation:

Article I

Corporate Name

The name of the corporation shall be "The Association of Classical and Christian Schools, Incorporated."

Article II

Nonprofit Status

The Association of Classical and Christian Schools, Incorporated, shall be a nonprofit corporation in conformity with the provisions of the Idaho Nonprofit Corporation Act, being Chapter 3, Title 30, Idaho Code.

Article III

Duration

The Association of Classical and Christian Schools, Incorporated, shall be a nonprofit corporation perpetual in its duration.

Article IV

Purposes

The Association of Classical and Christian Schools, Incorporated, is organized for the following purposes:

- A. Promoting, establishing, and equipping member schools committed to a classical approach to education in the light of a Christian worldview grounded in the Old and New Testament Scriptures, commonly known as the Bible.
- B. Charitable, religious, educational, or scientific within the meaning of Section 503(c)(3) of the Internal Revenue Code of 1986, as now enacted and as hereinafter amended.
 - C. To exercise all powers granted by law necessary and proper to carry out the

foregoing purposes, including, but not limited to, the power to accept donations of money, property, whether real or personal, or any other things of value. Nothing herein contained shall be deemed to authorize or permit The Association of Classical and Christian Schools, Incorporated, to carry on any business for profit, to exercise any power, or to do any act that a corporation formed under the Idaho Nonprofit Corporation Act, or any amendment thereto or substitute therefore, may not at that time lawfully carry on or do.

Article V Limitations

No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions (except as defined in Idaho Code Section 30-3-11(9)) in furtherance of the purposes set forth in Article IV hereof.

No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office.

Notwithstanding any other provision of these articles, the corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from federal income tax under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or (b) by a corporation, contributions to which are deductible under section 170(c)(2) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

Upon the dissolution of the corporation, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not so disposed of shall be disposed of by a court of competent jurisdiction of the county in which the principal office of the corporation is then located, exclusively for such purposes or to such organization or organizations, as said court shall determine, which are organized and operated exclusively for such purposes.
