The undersigned, being over the age of eighteen (18) years, as Incorporator of a Corporation under the Idaho Business Corporation Act, adopts the following Articles of Incorporation for such Corporation:

# ARTICLE I

PARTNERS OF THE RAINBOW, INC.

#### ARTICLE II

The duration of this corporation is perpetual.

### ARTICLE IX INDEMNIFICATION OF DIRECTORS

This corporation shall indemnify any director or officer of the corporation against judgment, fines, settlements, and reasonable expenses actually incurred by him or her in connection with the defense of any action, suit, or proceedings, civil or criminal, in which said person has been made a party by reason of being or having been such director or officer.

#### ARTICLE X BY-LAWS

The Board of Directors shall have the power to adopt, amend or repeal the By-Laws of this corporation, subject to the powers of the shareholders to amend or repeal such By-Laws.
