

ARTICLES OF INCORPORATION

OF

FOUR-H FARMS, INC.

KNOW ALL MEN BY THESE PRESENTS: That we, the undersigned, all natural persons of full age, citizens of the United States and residents of the State of Idaho, have this day associated ourselves together for the purpose of forming a corporation under the laws of the State of Idaho, and we do hereby certify:

1. Name. The name of the corporation is Four-H Farms, Inc.

2. Purposes. The nature of the business or purposes to be conducted or promoted are: to manufacture, design, construct, own, buy, sell, lease, hire, and deal in and with articles and property of all kinds and to render service of all kinds; and to engage in any lawful act or activity for which corporations may be organized under the laws of the State of Idaho.

3. Duration. The corporation shall have perpetual existence.

4. Location and post office address. The location of the registered office of the corporation and its post office address is Route 1, Box 62 A, Hazelton, Idaho 83335. The name of the registered agent of the corporation at such address is Lawrence Huettig.

5. Authorized shares. The aggregate number of shares which the corporation shall have authority to issue is 20,000 shares of the par value of \$10.00 each, all of one class, which shall be designated common stock.


