

ARTICLES OF INCORPORATION

MARIO ELECTRIC CONTRACTORS, INC.

THON ALL NAME AT THESE PRESENTS:

That we, the undersigned, WALTER H. CRIE, I. A. CCO:, and A. I. WENDELLS, all of Seattle, Wackington, and all being of full sie and altipons of the United States and residents of the State of Washington, have associated ourselves tagether for the purpose of forming a corporation under the laws of the State of Washington, and in purchase thereof do hereby si, a the following Articles of Incorporation in triplicate originals, stating as follows:

ANTICLE I: The corporate name of this corporation shall be NAMECO ELECTRIC CONTRACTORS, INC.

and time of existence shall be perpetual.

ANTICLE II: The objects and purposes for which the corporation is former are the following:

- 1. To early on and conjuct an electrical contracting business.
- 2. To construct, design, sell and install electrical wiring, facilities and equipment.
- 3. To buy, sell and cenerally seal in electrical machinery and equipment and other appointed types of machinery and equipment, both in domestic and foreign commerce, and to import or export as principal, broker, agent or factor such machinery and equipment and personal property.
- h. To apply for, obtain, register, purchase or otherwise acquire, and to hold, use, own and sell, or otherwise dispose of trade tarks, trade naces, copyrights, patents, inventions, improvements and processes used in connection with or secured under letters patent of the United States and foreign countries; and to use, exercise, develop or grant licenses in respect

of or otherwise turn to account any suc. trade marks, trade names, copyrights, patents, licenses, processes and the like, or any such property or rights.

- 5. To purchase, acquire, lease, rent, hold, own, use, sell, transfer, or in any manner dispose of, trade or deal in or in any manner turn to account as owner, principal, projer, agent, representative or attorney-in-fact, land and real estate of any and all hinds and classes, and in any and all of the sail capacities to erect, construct, build, lease, rent, use, equip, own, operate or in any manner turn to account lots, dwelling houses, warehouses, storehouses, of fice outlings, factories, and buildings of any and all hinds.
- 6. To acquire by purchase, subscription or otherwise, and to own, hold, sell, negotiate, assign, deal in, exchange, transfer, mortgage, pledge or otherwise dispose of any shares of capital stock, notes, bonds, dependences, mortgages, securities or evidences of indebtedness issued or created by any other persons, corporations, joint stock companies, or associations of this or any other state or county, and while holder or owner of any such shares of capital stock, notes, bonds, debentures, mortgages, securities or evidences of indebtedness, to possess and exercise in respect thereto any and all rights, powers and privileges of ownership, including the right to vote thereon.
- 7. To enter into and make, perform and carry out contracts, covenants and agreements of any kind and description for any lawful purpose, without limitation as to amount, with any person, firm, association or corporation, public or private, or any municipality, county, state, agency or subdivision thereof.
- 8. To purchase or acquire the whole or any part of the property, assets, rights, business, good will, and to assume the whole or any part of the bonds, notes, debentures, mortgages, franchises, leases, contracts, indebtedness, guaranties, liabilities and obligations of any person, firm, association or corporation, and to pay for the same in cash, shares of capital stock, bonds,

assuming the whole or any part of the liabilities or obligations of the transfervor, and to hold or in any manner dispose of the whole or any part of the property and assets so acquired, and to exercise all powers necessary or convenient in any about the conduct and management of any such obsiness.

- 9. To berrow money for its corporate purposes, and to make and issue notes, mortgages, conis, debentures and evidences of indebteuness of any and all linds, or to issue any of the same in payment for property, real or personal, or for any other lawful purpose in and about its business.
- 10. To bur, sell, discount, re-discourt, pleige, hapothecate and deal in notes, grafts, bills of sale and choses in action of all kinus and descriptions, both as principal and as agent for any other person, firm, association or corporation.
- ll. In general, to carry on any other business in connection with the foregoing, and to have and exercise all powers conferred by the laws of the State of Washington upon corporations formed under the laws of said State, and to up any and all things hereinbefore set forth to the same extent as natural persons might or could do.

ARTICLE IV: That the location and post office address of the registered office of this corporation shall be:

ABTICLE V: The authorized capital stock of this corporation shall nonsist of 500 shares of common stock, each share to be of the par value of \$100.00. Each share of such stock shall be entitled to one vote at all regular and special meetings of the shareholders. After payment of the subscription price the stock of this corporation shall not be assessable and no stock issued as fully par shall ever be assessed.

ALTICLE VI: The amount of paid-in capital with which this comparation will begin business is the value of \$500.00 or more.

ARTICLE VII: The number of directors of this corporation shall be not loss than three, her more than seven. The number, qualifications, terms of office, manner of election, time and place of meeting, and the powers and duties of the directors shall be such as are prescribed in the by-Laws of this corporation.
