The undersigned, each of whom is duly licensed to practice medicine in the State of Idaho, desire to form a professional corporation pursuant to Idaho Code §30-1301, et. seq., for the purpose of rendering medical services, and adopt the following articles of incorporation for such corporation:

ARTICLE ONE

NAME

The name of the corporation shall be Badger Medical, P.A.

ARTICLE TWO

PURPOSES AND POWERS

The purpose for which the corporation is formed is to engage in the general practice of medicine.

In connection with the above-mentioned purpose, the corporation shall have the power to invest its funds in real property and securities, to acquire, own, and dispose of real and personal property, and to do all other acts to the extent permitted under Idaho Code §30-1301, et. seq.
