#### ARTICLES OF INCORPORATION

SENTRY INDUSTRIAL SUPPLY AND PAINT COMPANY, INC.

We, the undersigned natural persons of the age of twentyone or more years of age, acting as incorporators of a corporation
under the Corporation Act of the State of Idaho, adopt the following
Articles of Incorporation:

## ARTICLE I

The name of this corporation shall be Sentry Industrial Supply and Paint Company, Inc.

#### ARTICLE II

The corporation shall exist for perpetuity unless dissolved according to law.

## ARTICLE III

- Section I. The corporation is organized for the specific purpose of buying and selling industrial supplies and paint.
- Section II. The corporation may engage in any and all other activities which corporations may do under the laws of the State of Idaho.

## ARTICLE IV

- Section I. The corporation shall have as many directors as the shareholders shall determine from time to time.
