ARTICLES OF INCORPORATION

OF

KNOW ALL MEN BY THESE PRESENTS, that I, the undersigned natural person of the age of twenty-one years or more, acting as incorporator under the Oregon Business Corporation Act, adopt the following Articles of Incorporation:

ARTICLE I

The name of the Corporation shall be CASEY ENTERPRISES, INC.

ARTICLE II

The duration of the Corporation shall be perpetual.

ARTICLE III

The purpose of the Corporation is to engage in any lawful activity.

ARTICLE IV

The principal office and place of business of the Corporation shall be at 1505 West Twelfth Avenue, Albany, Oregon, and the registered office of said Corporation shall be at 1505 West Twelfth Avenue, Albany, Oregon.

ARTICLE V

The total authorized stock of the Corporation shall be divided into 500 shares, all of which shall be without nominal or par value, and all stock shall be common stock with equal preferences, rights, privileges and restrictions.

Said shares without nominal or par value may be issued and sold from time to time by the Corporation, and for such consideration and upon such terms as may be from time to time fixed by the Board of Directors, without action or notice to the stockholders.

All or any portion of the stock of the Corporation may be issued for real or personal property, services, or any other right or thing of value for the uses and purposes of the Corporation, and when so issued shall become fully paid, the same as though paid for in cash, and the Directors shall be the sole judges of the value of any property, right or thing acquired in exchange for stock.

The Corporation shall have the power to purchase its own stock.

ARTICLE VI

The initial registered agent of the Corporation shall be:

ARTICLE VII

The number of Directors constituting the initial Board of Directors of the Corporation is three (3), and this number may be altered from time to time as may be provided in the By-Laws. In case of an increase in the number of Directors, the additional Directors may be elected by the stock-holders as provided in the By-Laws. The names and addresses of the

ARTICLES OF AMENDMENT

OF

CASEY ENTERPRISES, INC.

THE UNDERSIGNED, Rex Casey, President of Casey Enterprises, Inc. and Robert Morris, Secretary of Casey Enterprises, Inc. do hereby certify the following as the duly adopted amendment to the Articles of Incorporation of Casey Enterprises, Inc. and a summary of the proceeding relating to the adoption of the amendment of the Articles of Incorporation:

Article V. of the Articles of Incorporation is hereby amended to read as follows:

"ARTICLE V.

The total authorized stock of the Corporation shall be divided into ONE THOUSAND (1,000) shares, all of which shall be without nominal or par value, and all stock shall be common stock with equal preferences, rights, privileges and restrictions.

Said shares without nominal or par value may be issued and sold from time to time by the Corporation, and for such consideration and upon such terms as may be from time to time fixed by the Board of Directors, without action or notice to the stockholders.

All or any portion of the stock of the Corporation may be issued for real or personal property, services, or any other right or thing of value for the uses and purposes of the Corporation, and when so issued shall become fully paid, the same as though paid for in cash, and the Directors shall be the sole judges of the

value of any property, right or thing acquired in exchange for stock.

The Corporation shall have the power to purchase its own stock."

special meeting of the stockholders called for that purpose on the / pday of August, 1975, at 3:00 o'clock p.m. at the office of the corporation in Albany, Oregon. Said meeting was held pursuant to a call by the President and notice being duly given. The stockholders were present at the said meeting representing FIVE HUNDRED (500) shares of common stock of the outstanding stock of the Corporation. A total of FIVE HUNDRED (500) shares of common stock were voted in favor of the amendment as set forth and non of the shares were voted against the amendment. At the time of the adoption of these amendments, FIVE HUNDRED (500) shares of common stock were issued and outstanding and entitled to vote.
