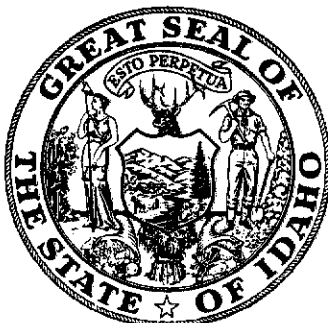

KNOW ALL MEN BY THESE PRESENTS, That we, the undersigned, being of full age and a citizen of the United States, do this day voluntarily form a corporation under the provisions of the Idaho Business Corporation Act, and we hereby certify in writing:

ARTICLE I: NAME

The name of the corporation shall be **STOLLDORF TRUCKING, INC.**

ARTICLE II: PURPOSE AND POWERS

The purposes for which this corporation is formed are to engage in any lawful act or activity for which corporations may be organized under the Idaho Business Corporation Act and to possess and exercise all the powers and privileges granted by the Idaho Business Corporation Act or by any lawful powers and privileges incidental thereto so far as such powers and privileges are necessary or convenient to the conduct, promotion or attainment of the business or purpose of the corporation, including the hauling of all and every kind of products produced upon farms, inclusive of milk, water, whey, grain, both within the boundaries of the state of Idaho and outside of the boundaries of the state of Idaho and including the operation of a feed lot and the raising of farm products.

ARTICLE III: DURATION

Subject to dissolution in the manner provided by law, the corporation shall be perpetual.

ARTICLE IV: REGISTERED OFFICE

The registered office of said corporation in the state of Idaho shall be located at 73 East 300 North, Rupert, Idaho, 83350. Daylon Stolldorf shall be the registered agent at the address set forth above.

ARTICLE V: CORPORATE STOCK

The aggregate number of shares which the corporation shall be authorized to issue is one thousand (1,000) shares of stock which has a no par value.

ARTICLE VI: INCORPORATOR

The following is the names and post office address of the incorporators:

ARTICLE VII: MANAGEMENT

The business of the corporation shall be managed by a Board of Directors of at least three (3), except that if all of the shares of the corporation are owned beneficially and of record by either one or two stockholders, the number of Directors may be less than three but not less than the number of stockholders. A Director shall hold office for the term for


which he or she was named or elected and until his or her successor is elected and qualified. The incorporators listed in Article VI above shall serve as the initial Directors until the first annual meeting of the shareholders or until their respective successors are elected and qualified.

ARTICLE VIII: BY-LAWS

The initial by-laws of the corporation shall be adopted by its Board of Directors. The power to alter, amend or repeal the by-laws or adopt new by-laws subject to repeal or change by action of the shareholders shall be vested in the Board of Directors.


