
### CERTIFICATE OF INCORPORATION OF

ARTICLES OF INCORPORATION  
of the

**VALLEY BAPTIST CHURCH OF HAGERMAN, ID., INC.**  
374 N. STATE STREET  
HAGERMAN, IDAHO

Be it known that we, the undersigned, all of whom are of full age and citizens of the United States and residents of the State of Idaho, do voluntarily associate ourselves together for the purpose of forming a non-profit, religious corporation under the laws of the State of Idaho, and particularly under Chapter 11 of Title 30 of the Idaho Code. and we hereby make, subscribe and execute the following Articles of Incorporation.

**ARTICLE I - NAME**

The name of this corporation shall be **VALLEY BAPTIST CHURCH OF HAGERMAN, ID. INC.**, Hagerman, Idaho.

**ARTICLE II - MEMBERSHIP**

The membership of the corporation shall consist of those persons who are members of the **VALLEY BAPTIST CHURCH OF HAGERMAN, IDAHO, INC.**, Membership qualifications shall be defined in the By-Laws of the corporation.

**ARTICLE III - REGISTERED OFFICE AND REGISTERED AGENT**

The registered office shall be 374 N. State Street, Hagerman, Idaho. The registered agent of the corporation shall be **WALTEN E. MILDREN, 374 N. STATE STREET (P. O. BOX 665)** HAGERMAN, IDAHO 83332.

**ARTICLE IV - PURPOSE**

The purpose of the corporation shall be to proclaim the Gospel of Jesus Christ, publicly and privately, locally and to the ends of the earth, to give its members and others opportunity for worship, to learn the teachings of the Bible, grow and mature spiritually and serve others as opportunity may afford.

## ARTICLE IV - DURATION OF THE CORPORATION

The duration of the corporation shall be perpetual, or until such time as it is terminated by a 2/3 majority of the members in good standing and present and voting at a meeting duly called for the purpose of disbanding the corporation.

In the event the corporation shall cease to exist, for any reason, the total assets will revert to the Magic Valley Baptist Association to be used for the above stated purposes by the same.

## ARTICLE VI - TRUSTEES

The assets and the operations of the corporation shall be held in trust by at least three (3) "Trustees". The trustees have been elected according to the constitution adopted by the VALLEY BAPTIST CHURCH OF HAGERMAN, IDAHO INC., November 14, 1993, and in keeping with the laws of the State of Idaho.

It is, further, the purpose of the corporation (church) to establish, own, and maintain a place, or places of worship and Christian education, to acquire by purchase, gift, devise or bequest personal property or real estate for the purposes of the corporation (church). The corporation (church), through its trustees, has the power to purchase, lease, rent, exchange, hire, buy, sell, mortgage or encumber, hold lands and tenements, improved or unimproved, real or personal, or any interest therein to carry out the stated purposes of the corporation (church), and to have and exercise any and all other powers granted by the laws of the State of Idaho to corporations organized for non-profit, religious purposes.

The corporation (church) is organized as a non-profit, religious corporation(church) and, therefore, does not afford pecuniary gain, incidental or otherwise, to its members.

The above powers shall be exercised only upon specific authorization by the VALLEY BAPTIST CHURCH OF HAGERMAN, IDAHO INC., by a 2/3 majority vote of the members in good standing present at a meeting duly announced for that purpose.

The VALLEY BAPTIST CHURCH OF HAGERMAN, IDAHO INC., elected from the trustees a "President" and "Secretary" for the corporation, who shall be the legal signators for the corporation.

The following trustees were elected by the church on Sunday, September 12, 1993 and shall serve as the initial incorporators and directors of the corporation. Procedures for the election of new Trustees shall be set forth in the By-Laws of the VALLEY BAPTIST CHURCH OF HAGERMAN,

ID INC., Hagerman, Idaho.
