

The undersigned, acting as the President of Valley Freight, Inc., a corporation organized under and pursuant to the Idaho Business Corporation Act, Chapter 1, Title 30, Idaho Code, on behalf of the shareholders adopts the following amendments to the Articles of Incorporation filed April 30, 1996.

ARTICLE I.

The name of this corporation shall hereafter be "Yelton Excavation, Inc."

ARTICLE V.

The address of the registered office of the corporation is 201 South Morgan, New Meadows, ID 83654, and the name of its registered agent at such address is Tina S. Yelton

ARTICLE VI.


