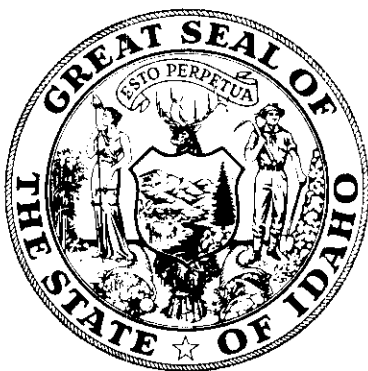

ARTICLES OF INCORPORATION
OF
FARM 301, INC.

KNOW ALL MEN BY THESE PRESENTS:

The undersigned, being a natural person of legal age and acting as incorporator of a corporation, under the Idaho Business Corporation Act, adopts the following Articles of Incorporation for such corporation:

FIRST:

The name of the Corporation is FARM 301, INC.

SECOND:

The period of its duration is perpetual.

THIRD:

The purpose for which the corporation is organized is the transaction of any or all lawful business for which corporations may be incorporated under the Idaho Business Corporation Act.

FOURTH:

The aggregate number of shares which the corporation shall have authority to issue is One Thousand shares (1,000) with a no par value. There shall be one class of shares, all of which shall be common shares.

FIFTH:

The address of the initial registered office of the corporation is 445 North Capital, Idaho Falls, Idaho, and the

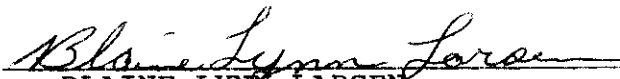

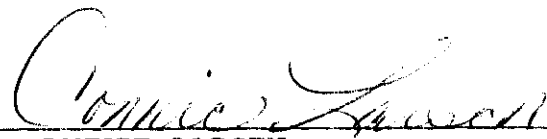

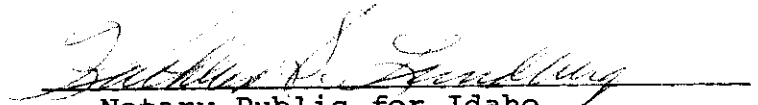
