**BYLAWS**


IDAHO SECRETARY OF STATE

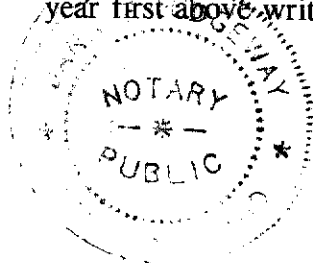

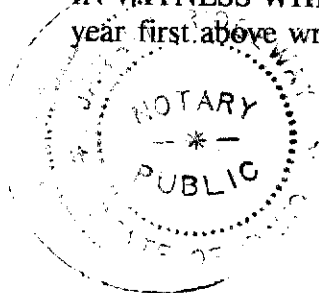
