Articles of Incorporation of the Sawtooth Wildlife Council, Inc.

RECEIVED

Articles of Incorporation of the Sawtooth Wildlife Council, Inc. desiring to form a Non-Profit Corporation under the Non-Profit Corporation Law of Idaho, do hereby certify:

First: The name of the Corporation shall be the Sawtooth Wildlife Council, Inc. 92 MAR 10 AM 8 32

Second: The place in this state where the principal office of the Sawtooth Wildlife Council, Inc. is to be located is the Stanley Community Building, Highway 75, City of Stanley, Custer County.

Third: The Sawtooth Wildlife Council, Inc. is organized primarily for the following purposes:

- To build upon education and awareness to further the protection of wildlife and habitat;
- To provide opportunity for active involvement in resource decisions that affect wildlife;
- To facilitate communication between resource agencies, people and organizations
- To share the enrichment of wildlife observation.

Fourth: The names and addresses of the persons who are the initial incorporators of the Sawtooth Wildlife Council, Inc. are as follows: Cathy Baer, Chair, Box 9116 HC 64, Ketchum ID 83340; Karen Shideler, Treasurer, Box 9123 HC 64, Ketchum ID 83340. The Initial registered agent is Cathy Baer, address 110 Vader Dr., Box 9116 HC 64, Ketchum ID 83340. The Sawtooth Wildlife Council, Inc. shall not have a board of directors.

Fifth: No part of the net earnings of the Sawtooth Wildlife Council, Inc. shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the Sawtooth Wildlife Council, Inc. shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article Third hereof. No substantial part of the activities of the Sawtooth Wildlife Council, Inc. shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the Sawtooth Wildlife Council shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office. Notwithstanding any other provision of these articles, this corporation shall not, except to an insubstantial degree, engage in any activities or exercise any powers that are not in furtherance of the purposes of this corporation.

Sixth: Upon the dissolution of the Sawtooth Wildlife Council, Inc. assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not so disposed of shall be disposed of by the Court of Common Pleas of the county in which the principal office of the corporation is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.

Amendment to Articles of Incorporation of the Sawtooth Wildlife Council, Inc.

The Fifth section, last sentence of said articles shall be amended to read as follows:

Notwithstanding any other provision of these articles, this corporation shall not carry on any other activities not permitted to be carried on by a corporation exempt from Federal income tax under Section 501(c)(3) of the Internal Revenue Code of 1954.

This amendment was adopted by a majority vote of the Advisory Committee at convened meeting of March 2, 1992.
