ARTICLES OF INCORPORATION  
OF  
DOSSCO, INC.

The undersigned, acting as incorporator of a corporation under the Idaho Business Corporation Act, adopts the following Articles of Incorporation for such corporation:

ARTICLE 1.

The name of the corporation is Dossco, Inc.

ARTICLE 2.

The period of its duration is perpetual.

ARTICLE 3.

The purpose for which the corporation is organized is the transaction of any or all lawful business for which the corporation may be incorporated under the Idaho Business Corporation Act.

ARTICLES 4.

The aggregate number of shares which the corporation shall have authority to issue is 100,000 with a par value of \$1.00 per share.

ARTICLES 5.

Shareholders shall have no preemptive right to acquire unissued or treasury shares or securities convertible into such shares or carrying a right to subscribe to or acquire shares.

ARTICLES 6.

At each meeting of shareholders, every shareholder of record of the corporation shall be entitled to one vote for each share of stock standing in his or her name on the books of the corporation. Shareholders shall not be entitles to vote their shares cumulatively in the election of directors of the corporation.

ARTICLES 7

The location of the initial registered office of the corporation is 9474 Fairview, Boise, Idaho 83704 and the name of its initial registered agent at such address is Eddie F. Dossey.

ARTICLES 8.

The number of directors constituting the initial board of directors is two, and the name and address of the persons who serve until the first annual meeting of the shareholders and until their successors are elected and qualified are:
