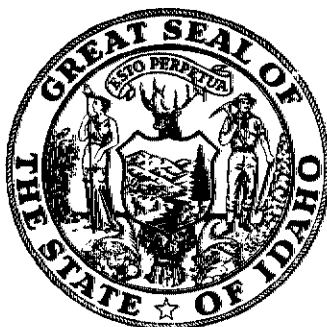

**ARTICLES OF INCORPORATION
OF
RAINIER RENTALS, INCORPORATED**

The undersigned, acting as incorporator of a corporation under the Idaho Business Corporation Act (Idaho Code § 30-1-1 et seq) adopts the following Articles of Incorporation for such corporation:

I. NAME

The name of the corporation is RAINIER RENTALS, INCORPORATED.

II. DURATION

The period of its duration is perpetual.

III. PURPOSES

The purposes for which this corporation is organized is to (a) rent real and personal property, houses and apartments, in Idaho and Oregon; (b) administer, manage and supervise the rental or property in Idaho and Oregon; (c) sell items of personal property and sporting equipment; and (d) transact all other lawful business for which corporations may incorporate or act under any law whatsoever.

IV. STOCK

The aggregate number of shares which this corporation shall have the authority to issue is ONE HUNDRED THOUSAND (100,000) shares common voting stock at \$10.00 per share par value.

**V. PRINCIPAL PLACE OF BUSINESS
AND REGISTERED AGENT**

The address of the initial registered office of the corporation is 109 North Arthur, Suite 303, Pocatello, Idaho 83201; and the name of its initial registered agent at such address is Charles Johnson.

VI. INITIAL DIRECTORS
