(a) To engage in the business of transporting timber, timber products and any and all other transporting by highway, railroad or streams, as private, contract or common carrier or otherwise; to acquire, operate and dispose of any and all types of machinery and equipment convenient for any of such purposes; to acquire, operate and dispose of timber lands and all rights and interest therein; to conduct logging operations, build, own and operate roads and power plants and to do any act or thing convenient to any of such operations; to acquire, operate and dispose of mills, millsites, leaseholds and franchises for the manufacture and purchase of wood products and engage in the business of production or otherwise acquiring, selling and dealing in lumber and all types of wood products; to acquire, operate and dispose of mines and mining interests; to acquire, own, operate, deal in and dispose of personal property of any kind, tangible or intangible, in any manner, at retail or whole sale; to acquire, own, operate and dispose of red estate; to guarantee performance of contracts by others; to borrow money and to mortgage, pledge or otherwise hypothecate its property as security for repayment thereof; to loan money with or without security; to assemble or manufacture any kind of personal property; to do any kind of building and construction work; to write insurance of any kind and conduct insurance loan and investment business or businesses; and generally to do any act and conduct any business or enterprise not prohibited by law. It may carry on its business and activities within or without the
