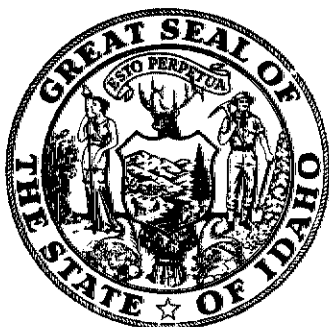

ARTICLES OF INCORPORATION
OF
SCHRANZ ELECTRIC, INC.

The undersigned, acting as Incorporator of a corporation under the "Idaho Business Corporation Act," adopts the following Articles of Incorporation for such corporation.

ARTICLE I

The name of the corporation is Schranz Electric, Inc.

ARTICLE II

The corporation shall have a perpetual existence.

ARTICLE III

The purposes for which said corporation is organized are electrical services and the transaction of any or all lawful business for which corporations may be incorporated under the "Idaho Business Corporation Act."
