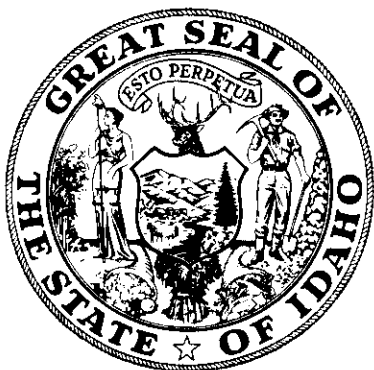



ARTICLES OF INCORPORATION
SECRETARY OF
STATE

NORTH WEST LABS, INC.

We, the undersigned persons, having voluntarily associated ourselves for the purpose of forming a private corporation under the laws of the State of Idaho, and to that end hereby adopt Articles of Incorporation as follows:

ARTICLE ONE

Name

The name of the corporation is North West Labs, Inc.

ARTICLE TWO

Duration

The duration of the corporation is perpetual.

ARTICLE THREE

Purposes

The corporation is formed for the following purposes:

1. To analyze, conduct and report research on milk for liquid or solid constituents, both normal and abnormal, for fat, protein, energy or other nutritive value, and for bacterial content or other disease related constituents; to analyze, conduct and report research on human and animal food or foodstuffs for all normal and abnormal constituents whether of nutritive value or contaminants, including but not limited to chemicals such as insecticides, toxins, both organic or inorganic; to analyze, conduct and report research on human and animal blood and body tissues for normal and abnormal constituents including but not limited to enzymes and proteins in general, minerals, vitamins, fat and other chemical or physical contents and bacterial, viral or other disease-related contaminants; to analyze, conduct and report research on soils for all normal or abnormal constituents of every form and type; to discover and develop the means and

ways by which milk productivity and the beneficial chemical content of human and animal foodstuffs may be increased and their nutritive and health giving qualities and values may be increased; to conduct generally the business of analytical and consulting chemists, to make analysis, inspections, formulae and to conduct research work; to build, construct, buy, sell, lease, rent, maintain, and conduct a laboratory or laboratories for chemical research work; to design, manufacture, buy, sell, lease, rent, maintain and generally deal in machinery, tools, appliances, devises, equipment and supplies used by manufacturing chemists and analytical and consulting chemists; to determine, by scientific investigation, study, experiments, and tests, the chemical content of the milk and livestock feed, and to ascertain, define and publish standards, classifications, and specifications, for milk, human, animal food or foodstuffs; to contract with others for the examination, classification, testing, and inspection of milk and animal or human foodstuffs; to report and circulate the results of such investigations and examinations to such others by the publication of such reports and examination as from time to time may be deemed advisable.

2. To purchase, to receive by way of gift, subscribed for, invest in, and in all other ways inquire, import, lease, possess, maintain, handle on consign, own, hold for investment or otherwise use, enjoy, exercise, operate, manage, conduct, perform, make, borrow, guarantee, contract in respect of, trade and deal in, sell, exchange, let, lend, export, mortgage, pledge, deed and trust, hypothecate, encumber, transfer, assign or in all other ways dispose of, design, develop, invent, improve, equip, repair, alter, fabricate, assemble, build, instruct, operate, manufacture, plant, cultivate, produce, market, and in all other ways (whether like or unlike any of the foregoing) deal in and with property of every kind and character, real, personal or mixed, tangible or intangible, wherever situated and however

held, including but not limited to, money, credits, choses in action, securities, stocks, bonds, warrants, script, certificate, debentures, mortgages, notes, commercial paper and other obligations and evidences of interest in or indebtedness of any person, firm or corporation, domestic or foreign, or of any government or subdivision or agency thereof, documents of title and accompanying rights, and every other kind and character of personal property, real property (improved or unimproved), and the products and avails thereof, and every character of interest therein and appurtenances thereto, including but not limited to mineral, oil, gas and water rights, all or any part of any ongoing business, and its incidents, franchises, subsidies, concessions, charters, grants, rights, powers or privileges, granted or conferred by any government or subdivision or agency thereof, and any interest in or part of any of the foregoing, and to exercise and respect thereof, all the rights, powers, privileges and immunities of individual owners or holders thereof;

3. To hire and employ agents, servants and employees, and to enter into agreements of employment and to act as agent, contractor, trustee, factor or otherwise, either alone or in company with others;

4. To promote or aid in any manner, financially or otherwise, any person, firm, association or corporation, and to guarantee contracts and other obligations;

5. To let concessions to others to do any of the things that this corporation is empowered to do and to enter into, make, perform, and carry out, contracts and arrangements of every kind and character with any person, association or corporation, or any government or authority or subdivision or agency thereof;

6. To carry on any business whatsoever that this corporation

may deem proper or convenient in connection with any of the foregoing purposes or otherwise, or that it may deem calculated, directly or indirectly, to improve the interest of this corporation, and to do all things specified in Section 30-1-1, et. seq. Idaho Code, more specifically known as the Idaho Business Corporation Act, and to have and to exercise all powers conferred by the laws of the State of Idaho, on corporations formed under the laws pursuant to which and under which this corporation is formed, as such laws are now in effect or may at any time hereafter be amended, and to do any and all things hereinabove set forth to the same extent and as fully as natural persons might or could do, either alone or in connection with other persons, firms, associations, or corporations, and in any part of the world.

The going statement of purposes shall be construed as a statement of both purposes and powers, shall be liberally construed in aid of the powers of this corporation, and the powers and purposes stated in each clause shall, except where otherwise stated, be in nowise limited or restricted by any term or provision of any other clause, and shall be regarded not only as independent purposes, but the purposes and powers stated shall be construed distributively as each object expressed, and the enumeration as to specific powers shall not be construed as to limit in any manner the aforesaid general powers, but are in furtherance of, and in addition to and not in limitation of said general powers. This corporation shall always have such incidental powers as may be connected with or related to any specific power herein enumerated.

The going statement of purposes shall be construed as a statement of both purposes and powers, shall be liberally construed in aid of the powers of this corporation, and the powers and purposes stated in each clause shall, except where otherwise

stated, be in nowise limited or restricted by any term or provision of any other clause, and shall be regarded not only as independent purposes, but the purposes and powers stated shall be construed distributively as each object expressed, and the enumeration as to specific powers shall not be construed as to limit in any manner the aforesaid general powers, but are in furtherance of, and in addition to and not in limitation of said general powers. This corporation shall always have such incidental powers as may be connected with or related to any specific power herein enumerated.

Nothing contained herein shall be construed as giving the corporation any rights, powers, or privileges not permitted to it by law, but the occurrence in any of the foregoing clauses of this article of any purpose, power or object, prohibited by the laws of the State of Idaho, or of any other state or of any district, territory, colony, dependency, or foreign country, in which the corporation may carry on business, shall not invalidate any other purpose, power or object not so prohibitive, by reason of contiguity or apparent association therewith.

ARTICLE FOUR

Location

The location, name, and post office address of the initial registered office and the initial registered agent is Bruce J. Bradley, 901 N. Lincoln, Jerome, Idaho 83352.

ARTICLE FIVE

Stock

The aggregate number of shares which the corporation shall have authority to issue is 200. The total authorized number of ^{no-}par value shares of stock is 200.


