ARTICLE V Internal Affairs of the Corporation

Section 1. <u>MEETINGS OF SHAREHOLDERS</u>: Meeting of the shareholders of the Corporation may be held at such place, either within or without the State of Idaho, as may be provided in the Code of By-laws.
