That we, the undersigned, all of whom are citizens of the United States and residents and freeholders of the state of Idaho, have this day voluntarily associated curselved together for the purpose of forming accrporation under the laws of the State of Idaho, and we hereby certify;

First. That the name of this corporation shall be *VELLINGTON COPPER AND GOLD MINING COMPANY, Limited. *

Second. That the purposes for which said corporation is formed are:

- 1. To purchase, acquire, own, hold, operate, rent, locate, improve, use, work. develop, lease, mortgage, sell, convey, and dispose of mines and mining claims of every kind and description, ditches, flumes, water and water rights, and other water and riparian rights, which shall be deemed necessary or convenient for its business, also mills, concentrators, smelters, reduction works electric light and power plants, lands, town and city lots, and any and all property incident, necessary or convenient for the uses and nurposes of this corporation.
