

ARTICLES OF INCORPORATION
OF THE
CULDESAC TRAMWAY COMPANY, LIMITED.

KNOW ALL MEN BY THESE PRESENTS, That we, the undersigned have this day voluntarily associated ourselves together for the purpose of forming a Corporation under the laws of the State of Idaho.

And we hereby certify:

First. That the name of the said Corporation is, "THE CULDESAC TRAMWAY COMPANY, LIMITED."

Second. That the purposes for which it is formed are as follows to-wit:

(a) To build, construct, own and operate a Tram Way built of wood or steel rails laid on wood cross-ties, the said road to extend from the Town of Culdesac, Idaho to a point at or near the mouth of Rock Creek, Nez Perce County, Idaho; the motive power of said road to be furnished by either horses, mules, steam or electricity.

(b) To build, construct and own all spurs, switches and buildings necessary to the proper operation of said road and to extend the same a distance of five (5) miles further whenever warranted by the business done.

(c) To purchase, buy, lease, or condemn under Eminent Domain all real property necessary for right-of-way and buildings necessary for the use of said road and all necessary spurs and switches. 2

(d) To engage general in the business of transporting freight for hire over and along said Tram Way between the terminals mentioned above and intermediate points along the said line of Tram Way.

(e) To erect maintain buildings at the terminal points and along the line of said road wherever necessary; to receive and store for hire personal property of every description at said buildings, and to buy and sell the same.

(f) To do generally all business, matters and things and buy, own, sell, use, transfer, acquire and operate any and all mechanical appliances necessary and convenient in and to said business and conducting the 3

affairs of said Company in executing any of the powers herein given and to do all things that may be necessary or proper for the complete enjoyment, use and benefit of said powers or any of them.

Third. The points from and to which the said Tram Way is intended to be operated is as follows: Commencing in the Town of Culdesac, Nez Perce County, State of Idaho, at or near the depot of the Northern Pacific R.R. Company and running thence in a South Easterly direction ⁴ through the said Town and following the course of Lapwai Creek to a point at or near the mouth of Rock Creek in Nez Perce County, State of Idaho.

Fourth: The estimated length of said Tram Way is Five Miles .

Fifth. That the place where its principal business is to be transacted will be the town of Culdesac, Nez Perce County, State of Idaho.

Sixth. That the term for which said Corporation will exist shall be fifty (50) years from and after the date of its incorporation.

Seventh. That the number of its directors shall be five (5) that ⁵ the names and residences of those who are appointed to act as Directors for the first year are:

Ninth. That the amount of the Capital Stock of this Corporation shall be Twenty thousand (\$20,000) dollars divided into Twenty thousand shares of the par value of One (\$1.00) dollar each.

Tenth. That the amount of the Capital Stock which has been actually subscribed is Ten thousand shares and the following are the names of the persons by whom the same has been subscribed, to-wit:
