



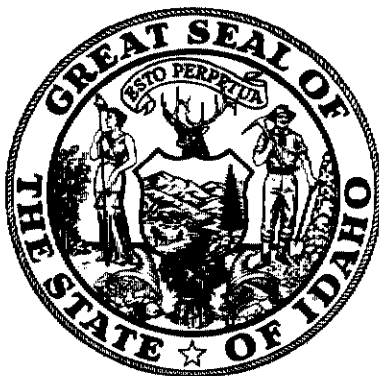
**CERTIFICATE OF INCORPORATION

COMES NOW Lavar Rindlisbacher as incorporator to incorporate this for-profit corporation according to the Laws of the State of Idaho to declare the following Articles of Incorporation:

ARTICLE ONE

The name of the corporation shall be Best Way Painting, Decorating and Maintenance, Inc.

ARTICLE TWO

Its duration shall be perpetual.

ARTICLE THREE

The purpose of the corporation is to operate a painting, decorating and property maintenance business and to transact any and all lawful business for which corporations may be incorporated under the Corporation Laws of the State of Idaho, including, but not limited to the general powers of the Idaho Corporation as outlined in 30-1-4 of Idaho Corporation laws.

ARTICLE FOUR

Until such time as the Board of Directors should amend these Articles to provide otherwise, the Corporation shall have authority to issue a total of One Hundred (100) shares of stock which initially shall be limited in distribution to no more than 15 shareholders. The stock shall be of one class, but it is specifically herein provided that 51 shares of said stock shall be issued to Lavar Rindlisbacher or his assigns in consideration for his contribution to the Corporation. All of the shares shall be issued without par value. All of the shares shall be of one class.

ARTICLE FIVE

By laws for the corporation are hereby authorized wherein procedures for internal operation of the corporation shall be set forth, including the procedures for amending these Articles of Incorporation.
