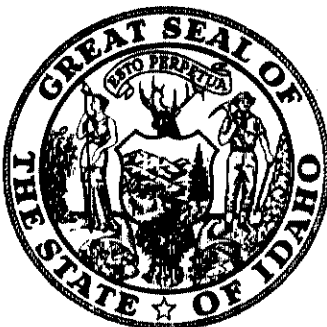
CERTIFICATE OF INCORPORATION OF

ARTICLES OF INCORPORATION
OF

SSC CONSTRUCTION INC

KNOW ALL MEN BY THESE PRESENTS: That I/we the undersigned national person(s) of lawful age and citizen(s) of the United States for the purpose of forming a professional corporation pursuant to the provisions of the Idaho Professional Service Corporation Act (Title 30, Chapter 13, Idaho Code) do(es) hereby certify as follows:

FIRST

The name of the corporation shall be
SSC CONSTRUCTION INC,
hereinafter called the Corporation.

SECOND

The Corporation is to have perpetual existence.

THIRD

The purpose for which the Corporation is formed is to engage as a professional service corporation in the practice of the profession of CONSTRUCTION as authorized by Section 30-1301, et seq, Idaho Code.

FOURTH

As limited by the laws of Idaho, the Corporation may practice said profession and operate offices throughout the State of Idaho.

FIFTH

The aggregate number of shares which the Corporation

shall have authority to issue is: 9

Such shares are to consist of one class only. The par value of each of such shares shall be \$650.

SIXTH

All of the shares of stock issued shall be of one class, and all shares shall have equal value, without preferences, limitations or differences in relative rights with respect to other shares.

SEVENTH

No person may become a shareholder in the Corporation who is not licensed to practice CONSTRUCTION in the State of Idaho. Should any shareholder cease, for any reason, to be licensed to practice GENERAL CONTRACTING in the State of Idaho, then that person shall cease to have voting rights in the Corporation (regardless of the number of shares owned) and that person's shares shall be treated as evidence of indebtedness of the Corporation and redeemed by the Corporation or purchased by an authorized, licensed person or persons as expeditiously as practicable.
