ARTICLES OF INCORPORATION

KNOW ALL MEN BY THESE PRESENTS: That I/we the undersigned national person(s) of lawful age and citizen(s) of the United States for the purpose of forming a professional corporation pursuant to the provisions of the Idaho Professional Service Corporation Act (Title 30, Chapter 13, Idaho Code) do(es) hereby certify as follows:

FIRST

The name of the corporation shall be <u>SSC CONSTRUCTION INC</u>

hereinafter called the Corporation.

SECOND

The Corporation is to have perpetual existence.

THIRD

The purpose for which the Corporation is formed is to engage as a professional service corporation in the practice of the profession of $\underline{CONSTRUCTION}$ as authorized by Section 30-1301, et seq. Idaho Code.

FOURTH

As limited by the laws of Idaho, the Corporation may practice said profession and operate offices throughout the State of Idaho.

FIFTH

The aggregate number of shares which the Corporation
