

Dear Ms. Villegas,

The Board received your attached request to use the name "Science and Engineering Associates, Inc." in Idaho. You further stated that your business entity is not required to engage a licensed professional engineer in the State of Idaho because the work performed by your business is in IT and engineering services in cybersecurity, systems engineering, network engineering, software engineering, spacecraft other vehicle systems engineering & integration (SE&I) [and does not involve professional engineering services as defined in 54-1202(11) Idaho Code]. You further stated in a phone call that the Idaho Secretary of State referred you to our agency to obtain a letter of authorization to use the above business name.

The Board considered your request at its meetings Aug 2-3, 2021 and voted to deny the request for an exemption from registration and a letter of authorization at this time. The Idaho State Board of Professional Engineers and Professional Land Surveyors has been steadfast in denying entities who do not employ Idaho licensed professional engineers to use the terms "engineer", "engineering" or "engineered" in its business name as registered with the Secretary of State. However, the Board always advises entities such as yours that it has no objection to your corporation doing business under a name that does not use such wording in its title. You obtain a different "DBA" by contacting the Secretary of State. Alternatively, we would also be happy to assist you in getting one of your engineers licensed in this state and then obtaining a Certificate of Authorization from the Board to allow the use of the name requested.
