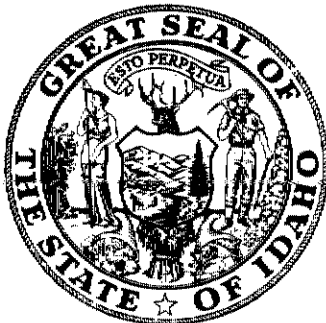

The undersigned, acting as incorporators of a corporation under the general corporation laws of the State of Idaho, do adopt the following Articles of Incorporation for such corporation.

ARTICLE I

The name of this corporation shall be W.O.M. TRANSPORTATION, INC.

ARTICLE II

The purpose of this corporation and the pursuits and business which it may carry on is the brokerage of contracts for hauling and transportation via the trucking industry; to obtain and maintain any necessary governmental authority to operate such brokerage; and all types of allied services.

In general, to carry on any other lawful business whatsoever in connection with the foregoing or which is calculated, directly or indirectly, to promote the interest of the corporation or to enhance the value of its properties.

ARTICLE III

The period of its duration is perpetual.

ARTICLE IV

The principal place of business of this corporation shall be 2724 Kopp Road, American Falls, ID 83211. The name and address of its authorized agent is Clint Robbins, 2724 Kopp Road, American Falls, ID 83211.

ARTICLE V

This corporation shall have management vested in the Board of Directors, consisting of two directors. The corporate powers, business and property of this corporation must be exercised, conducted and controlled by a board of two directors and a majority of said board may act so as to bind the corporation or its properties by action taken at any regular or special meeting.

There shall be a regular, annual, stockholders' meeting on the second Monday of March of each year, at 11:00 a.m., subsequent to the effective dates of these Articles of Incorporation, together with such other stockholders' meetings as shall be lawfully called for or provided for. The stockholders of this corporation shall not be individually liable for the debts of this corporation.

ARTICLE VI

The amount of authorized capital stock in this corporation shall be \$10,000.00, divided into 10 shares of par value of \$1,000.00 per share. No distinction shall exist between the shares of this corporation, or the holders thereof.

ARTICLE VII

All of the incorporators subscribed hereto are of full age and are citizens of the United States.

ARTICLE VIII

This organization shall have powers to lease, purchase, hold, and sell or convey property and to enter into any business transaction necessary for corporation purposes.

ARTICLE IX

Officers and Directors of this organization shall be elected by the members at the annual meeting. The number of officers and directors and all other matters relating to the management of the corporation shall be set out in the bylaws.

ARTICLE XI

The undersigned incorporators shall act as and shall constitute the initial Board of Directors until the first annual meeting and election is held.

ARTICLE XII

These Articles may be altered and amended at any meeting of the organization providing a quorum is present, by a majority vote of the members present at such meeting.

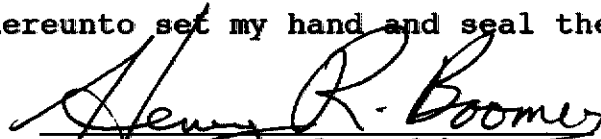
