Article 2: Purpose clause

Upper Country Education Foundation is a non-profit, volunteer-based organization organized to enrich the education of the students in the Cambridge School District by providing financial support, additional resources and opportunities for community collaboration.

The corporation is organized exclusively for charitable, educational, and scientific purposes under section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code.

This corporation is not organized for profit, and no part of the net earnings of this corporation shall inure to the benefit of any member of the Board of Directors or any other individual, except that this corporation may make payments of reasonable compensation for services rendered.

The corporation shall not participate or intervene in any political campaign on behalf of, or in opposition to, any candidate for public office to an extent that would disqualify it from tax exemption under section 501(c)(4) of the Internal Revenue Code. The corporation shall never be operated for the primary purpose of carrying on a trade or business for profit.

Article 8: Dissolution clause

Upon the winding up and dissolution of this Corporation, the assets of the Corporation remaining after payment of or provision for payment of all debts, obligations and liabilities of the Corporation shall be distributed to an educational organization, recognized as exempt under Section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code. This organization, to be designated by the board at the time of dissolution, shall use the assets received from Upper Country Education Foundation, Inc., exclusively to accomplish the purposes for which this Corporation is organized.
