ARTICLES OF INCORPORATION

of the IMPERIAL VALLEY HOMES, INCORPORATED

KNOW ALL MEN BY THESE PRESENTS that we, the undersigned, being natural persons of full age and citizens of the United States, and the State of Idaho, in order to form a general business corporation under the laws of Idaho, do hereby certify as follows:

I

The name of the corporation is to be IMPERIAL VALLEY HOMES, INCORPORATED.

II

That the purposes for which said corporation is formed are:

A. To build, furnish, equip and construct buildings, residential buildings, streets, highways, canals, water works, dams, and purchase, own, lease, sell or otherwise dispose of all necessary land, machinery, fixtures, and all apparatus necessary to fully build, furnish, equip, construct and operate all of the same and to purchase, lease, sell or otherwise acquire and dispose of such properties and lands herein defined and generally to transact all business connected with the said purposes or any of them.

B. To purchase, own, sell, lease, rent, manage residential homes, business buildings, apartments, industrial buildings, and any forms of structures and real property and generally to transact all business connected with the handling, sale and management of real property.

C. In general, to carry on any other lawful business whatsoever in connection with the foregoing or which is calculated, directly or indirectly, to promote the interest of the corporation or to enhance the value of its property and to perform all other acts which may be incidental to the property carrying on of the business of the said corporation.

D. In furtherance and not in limitation of the power conferred by the laws of the State of Idaho and by the principles of the common law, upon corporations organized under the provisions of the law authorizing the formation of this corporation, and for the purpose and powers hereinabove set, said corporation shall have the following purpose and powers being expressly provided that the enumeration of specific powers shall not be construed to limit or restrict in any manner aforesaid general powers of the corporation. ✓

III

This corporation shall be a general business corporation under the laws of the State of Idaho.

IV

The Corporation shall have perpetual existence.

V

Location and post office address of the registered office of the corporation is 2700 Idaho Avenue, Boise, Idaho, until the Board of Directors are elected and designate a more suitable office for the corporation.

VI

The total authorized common share value is ten thousand (10,000) shares of the par value of One Dollar (\$1.00) per share, the aggregate value of Ten Thousand Dollars (\$10,000.00) to be represented by stock certificates and one vote per share.

VII

The shares of the corporation shall be classified as common shares and will be represented by stock certificates No. 1 to 10,000 inclusive. The holder of these shares shall have a voting right of one vote per share as registered in his name on the corporate books, and the first right to participate in further sales of treasury common shares on the basis of shares in their name on the corporate books. ✓

VIII

IX

The corporation reserves the right to amend, change or repeal any provision contained in this certificate of incorporation, in a manner now or hereafter prescribed by law, and all rights and powers conferred hereof on the stockholders, directors and officers are subject to this reserved power.

X

These Articles may be amended by Resolution setting forth such amendment or amendments, adopted at the annual meeting of the stockholders by a vote of the majority of all of the corporation stock then represented.

XI

Until the first annual meeting of the stockholders and the election and qualification of the officers John H. Hiler, shall be president, and Fred W. Hiler, shall be vice-president, and Edna L. Rutherford, shall be secretary and treasurer.

XII

Until the first annual meeting of the stockholders and the election and qualification of the directors John H. Hiler, 1255 East 5th North, Mountain Home, Idaho, Fred W. Hiler, 1325 East 5th North, Mountain Home, and Edna L. Rutherford, 530 North 10th East Street, shall be the members of the Board of Directors.

XIII

The Board of Directors shall not consist of more than six members.
