do hereby certify and declare as follows

First

That said corporation shall be known
by the name of the William company.

Second

That the object of said corporation
shall be the operating and constructing
of toll roads including the road
commencing at Clawson toll gate
in Boise County, Idaho Territory and
running thence in a northerly direc-
tion to Sam Johnson summit, and
from said summit in a northerly
direction to Robies gulch near Robies
old mill site, all in said Boise County.

Third

That the amount of the capital stock
of said corporation shall be fifteen
hundred dollars, which shall be
divided into one hundred and fifty
shares of ten dollars each.

Fourth

That the said corporation shall exist
for the term of fifty years.
