ARTICLES OF INCORPORATION

OF

SANDPOINT REALTY COMPANY

We, the undersigned incorporators, being of full age, all of whom are citizens of the State of Idaho and of the United States of America, have this day voluntarily associated ourselves, for the purpose of forming a corporation under the laws of the State of Idaho, and we hereby certify:

FIRST: That the name of the corporation shall be "SANDPOINT REALTY COMPANY".

SECOND: That the purposes for which said corporation is formed are as follows:

To buy, sell, deal in, lease, hold or improve real estate, and with that end in view to acquire, by purchase, lease, hire or otherwise deal in, lands, tenements, hereditaments, or any interest therein, and to improve the property of the company, and to sell, lease, mortgage, pledge, or otherwise dispose of the lands, tenements and hereditaments or other property of the company; to construct, erect, equip, repair and improve houses, buildings, public or private roads, alleys, reservoirs and wharves; to make, enter into, perform and carry out contracts for constructing, altering, decorating, maintaining, furnishing, fitting up and improving buildings of every sort and kind; to advance money to, and enter into contracts and arrangements of all kinds with builders, contractors, decorators, dealers in stone, brick, timber, hardware and other building materials or requisites.

To borrow money; to lend money; to conduct a general brokerage, agency and commission business for others in the purchase, sale and management of real estate; to purchase and sell for others personal property, stocks, bonds, and notes, and to negotiate loans thereon for others; to act as trustee in deeds of trust or mortgages on real or personal property or any evidences of value to secure them; and to act as agents for letting houses and lands and the collection of rents and the payment of taxes.

To act as agent for insurance companies in soliciting and receiving applications for fire, casualty, plate glass, boiler, elevator, accident, health, burglarly, rent, marine, credit, fire, casualty, fidelity, and life insurance, and all other kinds of insurance, the collection of premiums, and doing such other business as may be delegated to agents by such companies, and to conduct a general insurance agency and insurance brokerage business.

THIRD: The period of existence of this corporation shall be perpetual.

FOURTH: The registered office and place at which the principal business of this corporation shall be conducted is the City of Sandpoint, County of Bonner, State of Idaho.

FIFTH: The total authorized stock of this corporation shall be twenty five thousand dollars (\$25,000.00), divided into two hundred fifty shares of the par value of one hundred dollars (\$100.00) per share.

SIXTH: The name, post office address and number of shares subscribed by each incorporator are as follows:

SEVENTH: The number of directors of this corporation shall not be less than three nor more than nine, and the number of directors, qualifications, manner of election, and the powers and duties of the directors shall be prescribed by the By-Laws.
