ARTICLES OF INCORPORATION
OF
R. F. ENTERPRISES, INC.

WE, THE UNDERSIGNED, being natural persons of the age of twenty One years or more and residents of the State of Idaho, and citizens of the United States, voluntarily agree and associate together to form a corporation under the laws of the State of Idaho, and declare said Articles of Incorporation to be as follows:

ARTICLE 1.

The name of this Corporation shall be R. F. ENTERPRISES, INC.

ARTICLE 2.

The principal place of business and post office address of this corporation is Soda Springs, Caribou County, Idaho, with such branch offices and places of business as this corporation shall deem necessary and expedient to the purposes and conduct of business thereof.

ARTICLE 3.

The period of existence of this corporation shall be perpetual or until otherwise disincorporated according to law.

ARTICLE 4.

The purposes and powers of this corporation shall be as follows:

a. To buy, sell, own, distribute, erect, construct, remodel, repair, affix additions to, any house, building erection or other type facility of every nature and kind.

b. To conduct the business of a general construction contractor, which business may include all kinds and types of construction and buliding. To buy, sell, own, and deal in all kinds of materials, equipment, supplies, vehicles,

together with any and all devices and activities now related to or hereafter to become related to this type of business.

c. To conduct the business of buying, selling, owning or to otherwise possess any and all building materials, supplies, now incident to or hereafter to become incident to building and construction, including all natural and synthetic products of every nature and kind.

d. To own, rent, purchase, sell or otherwise possess any motor vehicles or devices used in construction, building or contracting business which is or become incident to said business.

e. To employ personal in the conduct of the business as well as to conduct the business in any phase including general contractor, subcontractor, supplier, producer, distributor or in any other way of furnishing, selling, hiring, employing or otherwise using men and material.

f. To deal in, buy, sell, trade and otherwise possess or handle all types and kinds of appliances, fixtures or supplies used in houses or businesses of every nature and kind.

g. To buy, sell, trade, own or otherwise possess land, rights to land, interests in land, water and water rights and any other real property necessary to carry on the purposes of this corporation.

h. To subdivide lands for housing developments, business developments or any other use incident to the purpose of this corporation.

i. To purchase, hold, sell, improve and lease real estate and mortgage and encumber the same and to erect, construct, manage, care for and maintain, extend and alter buildings thereon, whether residential, business or otherwise, for the purposes of this corporation or for hire, rent, lease for this corporation or others.

j. To deal in all products for fuel and all products

in relation thereto.

k. To own, buy, sell, and/ or manufacture any or all types and kinds of automatic vending machines and locate or contract to locate, service and operate automatic vending machines.

l. To buy, sell, trade and deal in, at wholesale, retail or to distribute all types and kinds of recreation supplies, products, equipment, motors, vehicles and paraphernalia, including souvenirs, keepsakes and other recreation items of every nature and dexcription.

m. To buy, sell, trade and deal in at wholesale, retail or to distribute goods, supplies and wares of a general mercantile or merchandise business, including but not limited to cloth s of all types, footwear of all types and any other general merchandise.

n. To buy, sell, trade and deal in, at wholesale, retail or to distribute, groceries, provisions, foodsupplies, wares vegetables, produce, and all oth r articles and things incidental to a general grocery, vegetable, food supply, poultry, fish, game, produce and provision mercantile business.

o. To buy, sell, own and deal in automobiles and trucks, and all automotive supplies, devices and additions thereto, and to repair and care for the same including the operation of a automotive vehicle sales and service and operation of a petroleum business of every nature.

p. To deal in food and food products and beverages in selling, buying and serving same of every kind and nature.

q. To buy, sell, own or otherwise all personal property and real property to carry out the purposes of these articles.

r. To act in any way necessary under law to the conduct of the businesses aforesaid in thse articles including the

enforcement of all contracts, agreements and all actions at law.

The total authorized numbers of shares of stock of this corporation is 1000 shares of a par value of \$50.00 per share.


