Articles of Incorporation Spokane Mill Company

Know all men by these presents: That we
E. J. Brickell, J. J. Browne & M. Cannon, G. P. Bart,
H. M. Strathern, J. N. Giltranson & H. L. Richardson
do hereby associate ourselves as a corporation
under the general laws of the Territory of Washing-
ton and do hereby adopt the following articles of
Incorporation

Article I

The name of this corporation shall "The Spokane Mill Company"

Article II

The object and business of this corporation, shall be
1st To manufacture flour, meal, Woolen, Linen, and Cotton
goods, oil, Lumber, Shingles, Lath, speckets, Sash, doors, blinds,
Mouldings, furniture, and all kinds of house furnishing
and house furnishing goods, Upholstery goods and Wooden
wares, and to buy and sell the same, and to buy and
sell, Wheat, Oats, Barley, Corn, flax seed, and all
other farm produce, both at wholesale and retail
to buy and sell both at wholesale and retail agri-
cultural implements machinery, and goods, wares
and merchandise generally 2nd To purchase acquire
hold rent and obtain Mills and manufactories and
mill and manufacturing sites, Water Powers and
privileges, lands, improved and unimproved timber
lands logs and timber and towns and city lots and
property; and to erect build construct maintain
and operate upon its own or leased property
wherever situated, Mills and manufactories and
to build and construct all canals, aqueducts, flumes,
dams, warehouses buildings dwelling houses, offices
and superstructures as may be needed or deemed
expedient or necessary in conducting and operating
said milling manufacturing, lumber and mercantile
business, and may also lease mortgage, sell and
convey the whole or any part of its property.
3rd To borrow money, on bonds, notes, indentures or other
wise and to mortgage any of the property, real
or personal of this corporation to secure the payment
of the same, 4th To loan money on personal endorse-
ment, or upon personal or real estate security
and to take mortgages upon real estate or
personal property to secure loans made by it,
5th, Generally to do and perform everything necessary,
proper, or convenient to carry into effect the objects afore-
said

Article III

The Capital Stock of this corporation shall be, Two
Hundred and fifty Thousand dollars and such Capital

Stock shall be divided into twenty five hundred shares of One hundred dollars each.

Article IV

The duration of this corporation shall be fifty years

Article V

The corporate powers of this corporation shall be exercised by a board of seven directors or Trustees

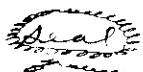
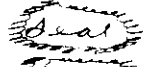
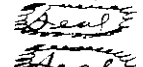
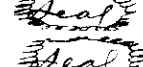
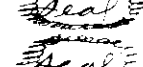
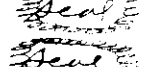
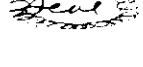
Article VI
