IN COMPLIANCE with the requirements of Title 30, Chapter 3, of the Idaho Code, the undersigned corporation adopts the following Articles of Amendment to its Articles of Incorporation:

ARTICLE I

The name of the corporation is ORCHARD ESTATES TOWNHOUSE OWNERS ASSOCIATION, INC.

ARTICLE II

The following amendments of the Articles of Incorporation were adopted on the 5th day of April, 1993, by written consent signed by all members entitled to vote with respect thereto, as required by Idaho Code 30-325-327:

The first paragraph of the Articles of Incorporation filed May 15, 1992 is hereby amended to read as follows:

In compliance with the requirements of Title 30, Chapter 3, of the Idaho Code, the undersigned, all of whom are owners of lots situated within ORCHARD ESTATES SUBDIVISION ORCHARD **ESTATES** or SUBDIVISION #2, located in the City of Nampa, Canyon County, Idaho, and all of whom are of the full age, have this day voluntarily associated themselves together for the purpose of forming a corporation not for profit and do hereby certify:

The Articles of Incorporation filed May 15, 1992, are further hereby amended to add the following article:

ARTICLE XI FHA/HUD/VA APPROVAL

As long as there is a Class B membership, the following actions will require the prior approval of the Federal Housing Administration (FHA), Department of Housing and Urban Development (HUD), or the Veterans Administration (VA): annexation of additional properties, mergers and consolidations, mortgaging of any Common Area, dedication of any Common Area, dissolution and amendment of these Articles.
