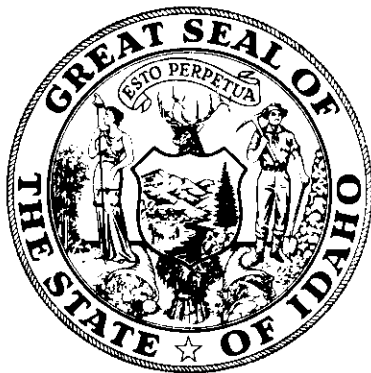

Pursuant to the provisions of Section 30-1-61 of the Idaho Business Corporation Act, the undersigned corporation adopts the following Articles of Amendment to its Articles of Incorporation;

FIRST: The name of the corporation is INTERPRETIVE DYNAMICS, INC.

SECOND: The following amendments of the Articles of Incorporation were adopted by the incorporator of the corporation on June 1, 1984, in the manner prescribed by the Idaho Business Corporation Act:

That Article "Fourth-Shares" of the original Articles of Incorporation be deleted in its entirety and the following substituted in lieu thereof:

FOURTH - SHARES:

The authorized amount of capital of this corporation shall be, and is, 1,000,000 shares of common stock with a par value of one dollar (\$1.00), which stock shall not be issued until fully paid for and once so issued shall be nonassessable. There shall be two classes of stock, as follows:

1. CLASS A shares, which shall consist of 600,000 shares which shall have voting right.

2. CLASS B shares, which shall consist of 400,000 shares and which shall not have voting rights.

THIRD: The number of shares of the corporation outstanding at the time of such adoption was none; and the number of shares entitled to vote thereon was none.
