AMENDED ARTICLES OF INCORPORATION
OF
STATE

KOOTENAI COUNTY JEEP SEARCH & RESCUE, INC.

The President and Secretary of the above captioned corporation respectfully submit the following amendment to the Articles of Incorporation of Kootenai County Jeep Search & Rescue, Inc. so that as amended, the Articles of the corporation shall read as follows:

ARTICLE I

The name of this non-profit corporation is: The Kootenai County Jeep Search & Rescue, Inc.

ARTICLE II

The duration of this corporation shall be perpetual.

ARTICLE III

The purpose or purposes for which the corporation is organized are:

1. To serve the public welfare in any disaster, catastrophe or emergency.
2. To work for the solution of the problems of search, rescue and law enforcement, civil defense or other authorized agencies in the State of Idaho.
3. To render aid and assistance to persons in difficulties or in distress when met on the road or in the field.
4. To render aid when called upon by local government law enforcement agencies, civil defense or other authorized agencies.
5. To correlate the activities of and encourage and strengthen and join together the various local jeep patrols located in Kootenai County, and to assist in the accomplishment of their aims and desires.

6. To associate together in meetings, gatherings and in the field for the furtherance of search and rescue.

ARTICLE IV

The names and addresses of the incorporators of this corporation are as follows:

ARTICLE V

The principal place of business and principal office of the corporation shall be: P. O. Box 591, Post Falls, Idaho 83854.

ARTICLE VI

Any person shall be eligible for membership in this corporation who subscribed to the objects and purposes hereof and such person shall be selected for membership in the manner provided by the By-laws, which members may be unlimited in number. There shall be but one class of membership, each member holding equal rights with all other members.

ARTICLE VII

The affairs of this corporation shall be conducted by a Board of Directors of at least five (5) and not more than nine (9) in number, with the exact number, manner of selection and qualifications as determined by the By-laws. Directors of this corporation shall be members, as may be determined by the By-laws.

ARTICLE VIII

This corporation is organized exclusively for religious, charitable, scientific, literary or educational purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code. This corporation is not organized for pecuniary profit and shall not issue capital stock; the corporation shall issue membership certificates to each of the members, which certificates shall be non-transferable or non-assignable except by resolution of the Board of Directors and under such regulations as the By-laws of this corporation may prescribe. Upon the winding up and dissolution of this corporation, after paying or adequately providing for the debts and obligations of the organization, the remaining assets shall be distributed to a non-profit fund, foundation or corporation which has established its tax exempt status under Section 501 (c)(3) of the Internal Revenue Code. All of the properties and assets of this corporation shall be and are irrevocably dedicated to the purpose for which this corporation is formed and no part of the monies, properties or assets of this corporation upon dissolution or otherwise shall inure to the benefit of any member of this corporation or to any private person or individual.

ARTICLE IX

Notwithstanding any other provision of these articles, the corporation shall not carry on any other activities not permitted to be carried on by an organization exempt from Federal Income Tax under Section 501(c)(3) of the Internal Revenue Code.

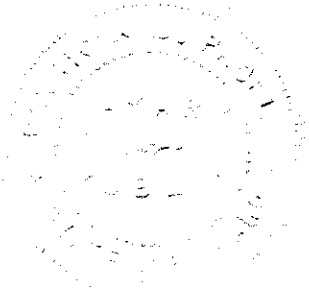
