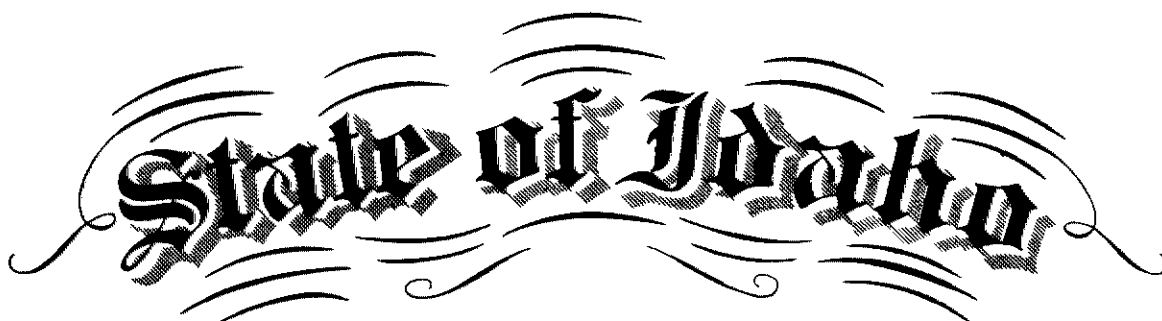

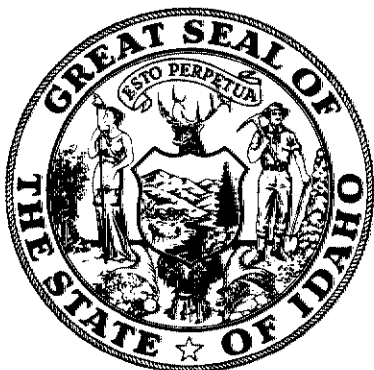

OF THE

These Articles of Incorporation are signed in duplicate and acknowledged by the incorporators for the purpose of forming a non-profit, educational, and research corporation under the provisions of Chapter 3, Title 30, Idaho Code as Follows:

1. The name of the corporation is the IDAHO WOMEN'S NETWORK, INC..

2. The corporation is a non-profit corporation.

3. The period of duration is perpetual.

4. The purposes for which this corporation is organized are as follows:

The Idaho Women's Network, Inc. is a statewide, broad-based nonpartisan coalition of organizations and individuals, and will take action to improve quality and opportunity in women's lives in Idaho. The Network will strengthen the advocacy voice for women in Idaho through shared information, ideas and action.

5. The location of this corporation is in the City of Boise, County of Ada, State of Idaho. The post office address of the registered corporation shall be P.O. Box 1385, Boise, Idaho 83701. The Street address shall be 104 S. Capitol Blvd., Boise, Idaho 83702. The name of the registered agent at this address is Susan M. Graham.

6. The corporation has members and the management of its affairs in to be vested in its members pursuant to section 30-314(c), Idaho Code, as set forth in the corporate bylaws.



corporation has no members.


