## ARTICLES OF INCORPORATION

KNOW ALL MEN BY THESE PRESENTS that we the undersigned being of full legal age and citizens of the United States, have this day voluntarily associated ourselves together for the purpose of forming a corporation under the laws of the State of Idaho, and hereby adopt Articles of Incorporation as follows:
