ARTICLES OF INCORPORATION  
FOR  
IMAGENet, Inc.

The undersigned, acting as incorporator of a corporation under the Idaho Business Corporation Act, adopts the following Articles of Incorporation for such corporation.

ARTICLE I.

Name

The name of the corporation is IMAGENet, Inc.

ARTICLE II.

Duration

The period of duration of this corporation is perpetual.

ARTICLE III.

Purposes

The purpose for which this corporation is organized is to transact any or all lawful business for which corporations may be incorporated under The Idaho Business Corporation Act.

ARTICLE IV.

The total authorized capital stock of the corporation shall be 100,000 shares, all of which shall be common stock without nominal or par value.

Preemptive Rights
